COMMITTEE REPORTS

Fire: Chief Tremain passed out the May run totals with 73 calls for the month.

<u>Police:</u> Chief Combs advised that they are still working with Lawrenceburg Schools on resource officers. Mayor Mollaun stated that a trained resource officer will be at each school building by August and will be an employee of the school.

EMS: Director Bobby Mills advised that the EMS Department had received 176 calls in the month of May. Allen Callaway gave kudos to the EMS and Fire Departments for their response and dispatch times.

1. Chief Combs stated that he would like to hire two new police officers. He said the Police Department has been short staffed for a while and have had a lot of overtime due to understaffing.
